A LETTER FROM OUR PRESIDENT

To All Members of IPA:

Greetings

We are beginning our sixth year with a tremendous amount of enthusiasm and the committed energies of many people.

Throughout this year, I wish to share with you in the Newsletter, my thoughts about the identity and function of the IPA. Putting these ideas into concrete form will also help me define the functions of the presidency.

Now for a bit of history. In May of 1977, Tom Rose, secretary/treasurer of IPA, resigned and Armand DiMele and Charlotte Saunders took over the work of the organization in mid-stream. They not only succeeded in keeping us together, but in organizing both an Eastern Regional Conference and our Lenox Convention. It was a fantastic feat and we thank them.

Additional history. At our first convention in Montreal, the decision to call ourselves the International Primal Association was overwhelmingly endorsed. In taking on the name, we were also throwing down the gauntlet to

Janov. There were some dissidents -- I was one -- but the groundswell was for the right to use the term PRIMAL.

In 1975, The Primal Feeling Center of New England came to us to ask us to support a fight to cancel Janov's trademark. Again, the groundswell feeling was overwhelmingly positive. I still had misgivings. We joined the fight. Since then, we have been involved as petitioners in a lawsuit against Arthur Janov. On October 11 there was an oral hearing in Washington, thus ending the first phase of our suit. Our attorney expects us to win, but expects Janov to appeal. The litigation has been costly. After October, we will owe our attorney \$2500. Though I originally preferred to avoid a head-on collision with Janov, I now recognize the importance of the fight. It seems immoral to me to popularize a new way of working with and understanding people and then treat it like a product which no one may touch. Ideas get lost in a struggle for profits. Should he win, he will set an important precedent. If we trademark ideas, others can no longer learn to use them or be innovative with them without the threat of expensive lawsuits. This would stifle movement, growth, and creativity throughout the psychotherapeutic community.

Joe Sanders was present at the oral hearing, and for the first time we now have direct contact with what is happening in court. I will report develop-

ments.

A LETTER FROM OUR VICE-PRESIDENT

Warm Greetings to All My IFA Friends,

I write this letter during my second day back from the 5th Annual IPA Congress at Belvoir Terrace, wanting to capture and communicate to you a few moments of the flow of excitement, warmth and delight that I am feeling. What a special time it was and remains for me!

Being with so many old friends and serendipitously discovering new ones; enjoying the presentation of my workshop and its enthusiastic reception (and the helpful feedback) marking another important step in my own growth as a more whole person and therapist; election to the vice-presidency of the IPA, which was such a wonderful surprise to me!--the respect is mutual.

Perhaps the most important impression I returned with was the feeling of greater wholeness that I experienced in those of us who have been on this primal trip: the deeper integration of feeling/thinking, emoting/acting, self confidence/humility. Profound change is possible! You are, I am the proof. I celebrate WE.

My most deeply felt impressions of this came during and after the presentation/discussion of two Leboyer films led by Natalie Garfield. So many feelings from that: the depth of our openly felt and shared early hurt and the subsequent yearning for loving touch, for consolation, for healthy reintegration; the poignant awareness of the tragic beauty of a people who have dared travel

all the way to the pits of this early childhood hell seeking to reconnect with the spontaneous, natural being within; the clarity and perceptiveness of our thinking that generally characterized our discussion of such raw experiential material. And while this was happening we witnessed the natural, flowing relationship between a mother and her infant daughter present there in Lenox-a concrete embodiment of hope for the creation of real, healthy children in our own time as well as a pain-filled reminder of our own un-natural childhood development. All in all, a most sad, joyous, and thoughtful evening.

As your vice-president, I, and a group of very energetic and talented committee members, have already begun planning next year's Congress. Any suggestions that you would like to send me regarding potential sites (we're looking in the Toronto area), ideas for workshops, themes, food, etc. will be seriously considered in our planning. This is a People's organization so let

your voice be heard!

I'm looking forward to hearing from you.

A Financial Report was presented.

The Ethics & Standards Committee will re-evaluate the method used to process complaints.

Law Suit - There will be an October 11th oral hearing in Washington, D.C. on Janov's suit on the use of the service mark "primal therapy."

A Newsletter Committee was established headed by Diane Bethune Zeines with Beverly Kopf, Dan Miller, Charlotte Saunders, Jean Getoff & David Newman. The newsletter will include a monthly calendar of area events.

Primal Community Report - Susan Cohn. A motion was made by Susan Cohn and seconded by Bill Goss to read: "The Editorial Board will consist of the present active members plus 4 alternates." It was unanimously passed. Elected to fill the Editorial Board were: Stephanie Callas, Loretta Fogel, Jacqui Leichter and Bernie Grater.

It was proposed by Susan Cohn and seconded by Stephanie Callas that the individual newsstand cost of an issue of Primal Community be \$3.00 per issue. The subscription rate will be for 2 issues per year at \$5.00 in U.S. funds. The motion passed with 16 yes and 8 no votes.

Annual Convention Feedback - It was suggested that the conference have an opening and closing common experience. It was also proposed that our next Annual Conference be concerned with emphasizing a sense of community.
